

I'm writing to ask you to join with Oregon Moms Demand Action for Gun Sense and tens of thousands of moms, dads, aunts, sisters, and brothers across Oregon who support background checks on all gun sales.

Gun sense starts by passing policies proven to keep guns out of dangerous hands. Currently in Oregon, people who are prohibited from purchasing firearms can buy guns with no background checks and no questions asked through private, unlicensed sales from strangers on the Internet. Oregon is the only state on the West Coast that hasn't closed this dangerous loophole.

This year our top legislative priority is comprehensive and enforceable criminal background checks, a life-saving policy supported by 87 percent of Oregon voters. ⁴⁶ We are asking you to join us by endorsing this sensible legislative reform. Passing the bill would level the playing field—making sure all Oregonians pass the same background check when buying a gun. The bill includes reasonable exceptions for self-defense, hunting, and transfers between immediate family members.

The claims made by opponents of closing the loophole simply don't stand up against the facts. As you're considering this issue here's what you need to know:

- Background check laws work. In states with background checks on all handgun sales, 48% fewer law enforcement are killed with handguns.
- Oregon's current background check system is quick and efficient. Oregon licensed dealers conduct tens of thousands of background checks each year, blocking 3,982 gun sales to prohibited people, including felons, domestic abusers, and other dangerous people in 2013 alone. 47 94.6% percent of Oregon residents live within 10 miles of a licensed gun dealer who is authorized to run background checks. 48
