

**PROPOSED AMENDMENTS TO
HOUSE BILL 2463**

1 On page 1 of the printed bill, line 2, delete “and”.

2 In line 3, before the period insert “; and declaring an emergency”.

3 In line 12, after the second “who” delete the rest of the line and delete
4 lines 13 and 14 and insert “possesses a valid license that the Department of
5 State Police has determined by rule is a reciprocal license under section 6
6 of this 2009 Act.”.

7 On page 2, line 3, after the second “who” delete the rest of the line and
8 delete lines 4 and 5 and insert “possesses a valid license that the Department
9 of State Police has determined by rule is a reciprocal license under section
10 6 of this 2009 Act.”.

11 In line 20, after “license” delete the rest of the line and delete lines 21
12 and 22 and insert “that the Department of State Police has determined by
13 rule is a reciprocal license under section 6 of this 2009 Act.”.

14 In line 45, after the second “who” delete the rest of the line and insert
15 “possesses a valid license that the Department of State Police has determined
16 by rule is a reciprocal license under section 6 of this 2009 Act.”.

17 On page 3, delete lines 1 and 2.

18 In line 41, after “and” delete the rest of the line and delete lines 42 and
19 43 and insert “possesses a valid license that the Department of State Police
20 has determined by rule is reciprocal license under section 6 of this 2009
21 Act.”.

22 Delete line 45 and delete page 4 and insert:

1 **“SECTION 6. (1) As used in this section, ‘reciprocal license’ means**
2 **a license or permit issued in another state by a state or local law**
3 **enforcement agency, a court or another issuing authority that au-**
4 **thorizes the licensee or permittee to carry a concealed handgun in the**
5 **state in which the license or permit was issued, if the other state:**

6 **“(a) Authorizes a person who is licensed under ORS 166.291 and**
7 **166.292 to carry a concealed handgun in the other state; ~~or~~ *AHP***

8 **“(b) Imposes eligibility requirements for the issuance of the license**
9 **or permit that are substantially similar to the requirements of ORS**
10 **166.291 and 166.292.**

11 **“(2) The Department of State Police shall adopt rules that identify**
12 **states that issue reciprocal licenses.**

13 **“SECTION 7. (1) Section 6 of this 2009 Act and the amendments to**
14 **ORS 166.173, 166.260, 166.262, 166.370 and 166.663 by sections 1 to 5 of this**
15 **2009 Act become operative on, and apply to conduct occurring on or**
16 **after, January 1, 2010.**

17 **“(2) The Department of State Police may adopt rules or take any**
18 **other action before the operative date specified in subsection (1) of this**
19 **section that is necessary to enable the department to exercise, on or**
20 **after the operative date specified in subsection (1) of this section, all**
21 **the duties, functions and powers conferred on the department by this**
22 **2009 Act.**

23 **“SECTION 8. This 2009 Act being necessary for the immediate**
24 **preservation of the public peace, health and safety, an emergency is**
25 **declared to exist, and this 2009 Act takes effect on its passage.”.**
