In the interest of public safety and the reduction of firearms related accidents and the unauthorized use of firearms, the people of Oregon resolve:

Section (1) Oregon public schools shall provide, in the sixth grade, a class for all students that provides firearm's safety instruction. The class shall be offered once during the school year. The length of the class shall be no less than 30 minutes.

Section (2) "Firearms safety instruction" means a class taught by a firearms instructor certified by law enforcement or a national or statewide organization that certifies firearms instructors and includes the following:

- (a) How to respond to an unsecured firearm. (If possible leave the location and call an adult)
- (b) How to safely secure a firearm if no adult is available and other children are present and leaving the area is not an option.
- (c) Safe muzzle direction and the importance of never touching a trigger if a firearm absolutely must be handled.
- (d) How semi-automatic firearms operate to demonstrate that removing the firearm's magazine does not mean the firearm is unloaded.

Section (3) The class described in Section (2) can be provided by a live instructor or electronically via teleconferencing, recorded video or other electronic remote information delivery method. Students will be tested on the material covered in the class after completion of the class.

Section (4) The required class shall include no material encouraging or discouraging firearms possession or purchase.

Section (5) At no time will any live ammunition be permitted in the firearms safety class.

Section (6) The parent or legal guardian of any student subject to the safety class described in Section (2) of this measure shall have the option of notifying the student's school that the student will not participate in the firearms safety class and no student whose parent or legal guardian who makes such notification shall be required to attend the class.
